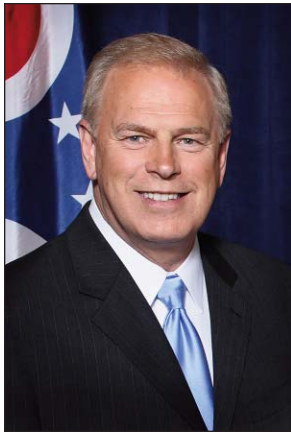


Co-Chair's Letter

Governors Applaud Great Lakes Funding Bill

On May 5, the Great Lakes Governors expressed their support for the Great Lakes Ecosystem Protection Act of 2010 (HR 4755 and S 3073). The House and Senate bills, sponsored by Representative Ehlers (R-MI) and Senator Levin (D-MI), would authorize the President's Great Lakes Restoration Initiative and the federal Interagency Task Force, reauthorize the Great Lakes National Program Office, and create a new management structure to coordinate our collective Great Lakes efforts.

As Council Co-Chairs Governor Doyle and Strickland noted in their letter to Congress, "[t]he bills are a strong expression of Congressional intent to invest significant additional resources in Great Lakes protection and improvements, while seeking coordination throughout the region."

Congress approved \$475 million for the President's Great Lakes Restoration Initiative this year and important protection and restoration work is already underway as a result. From April 10-20, the Council led a 30-member trade delegation to São Paulo, Brazil; Santiago, Chile; and Lima, Peru. The delegation comprised 18 small to medium sized companies from Minnesota, Ohio and Wisconsin representing a variety of sectors including agriculture, automotive, construction, finance, machinery and equipment, oil and gas, plastics, water and wastewater. Seven of the 18 companies had participated in previous Council missions.

The Council's Trade Offices in Brazil and Chile provided companies with extensive market research

reports and arranged customized appointment schedules with potential distributors, partners and end users. In addition, the

Council's team coordinated country business briefings, networking events and ground logistical support for hotels, transportation and interpreters.

Gary Ellerhorst, President/CEO of Crown Plastics located in Cincinnati, Ohio said, "The trip helped me identify various potential business development channels for South America, and educated me on the various pros and cons for doing business in each country. I also obtained some good general and legal enlightenment from the country business briefings. I am planning a return trip to the region within 6

months." Crown Plastics is a leading producer of thin gauge, high molecular weight polyethylene. They are a major supplier to the ski and snowboard industry and also provide material for countless industrial applications.

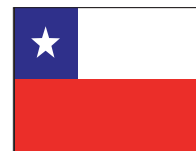
"For Safway Services, the mission was a great success," said Darrell Domokos, International Equipment Sales Manager for the company. "I think we have some



Compact Council and Regional Body to Meet June 10 in Chicago

The Great Lakes—St. Lawrence River Basin Water Resources Council (Compact Council) and the Great Lakes—St. Lawrence River Water Resources Regional Body (Regional Body) will hold public meetings this week in Chicago. At that time, they will consider new interim guidance and procedures; next year's budget; and hear from the public. Information is also available on the Compact Council's website which just recently went live at www.gslcompactcouncil.org. In addition to meeting information, the Compact Council site includes resolutions, guidance statements and other records. The site also includes a searchable water use baseline database that will be used for future decision-making. The Council of Great Lakes Governors serves as Secretariat to the Compact Council and Regional Body.

Conference Advances Great Lakes Science Strategy

Since the signing of the Great Lakes—St. Lawrence River Basin Sustainable Water Resources Agreement in 2005, the Council of Great Lakes Governors has helped to coordinate a series of actions to help advance the region's science strategy. Most recently, on May 19, the Council again participated in the International Association of Great Lakes Researchers conference. Laura Seaman of the Council staff presented a session, "Assessing and Managing Water Use Impacts in the Great Lakes Basin" at the conference held in Toronto, Ontario. Other presentations addressed other science issues related to the Agreement and the companion "Great Lakes Compact." 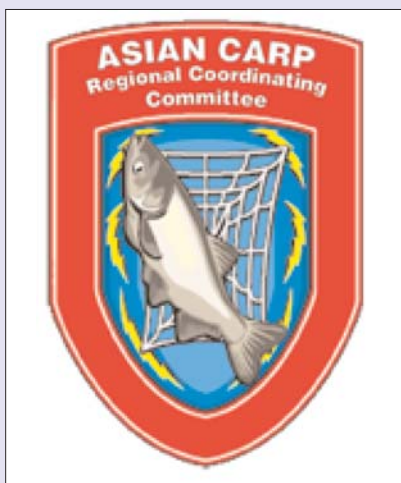
The EU hosts about 15 Americans each year for its policy-focused program. Follow-up activities are already taking place.

Asian Carp Hunt Continues in Chicago-Area Waterways



The U.S. Environmental Protection Agency and partners, known as the Asian Carp Regional Coordinating Committee (RCC), recently applied fish poison (rotenone) in the Little Calumet River. The RCC are working to identify the fish in this area and whether Asian Carp are present upstream of the electrical barriers designed to deter them.
